Subject: Information on appointing supervising and managing persons in OPTeam SA.

**Legal basis:** §5 section 1 item 22 of the Ordinance of the Minister of Finance of 19 February 2009 on current and interim information submitted by the issuers of securities, and on conditions of considering as equivalent the information required by law of a non-member state.

## **Report content:**

The Management Board of OPTeam SA (the Company) discloses information on changes in the composition of supervising and managing persons. On 12 June 2014 the Ordinary General Meeting of OPTeam SA appointed the following persons to the Supervisory Board of the Company of fourth term:

### 1) Janusz Bober

He graduated from Rzeszów University of Technology in 1983 and obtained the Master of Science degree at Electrical Department with major in automatics and metrology. In 1988 he completed post-graduate studies in IT science organized by the University of Warsaw and Polish Academy of Science. In 2007 he obtained the MBA degree from Oxford Brooks University in co-operation with Polish Open University.

Professional career:

1983 - 1987 Rzeszów University of Technology, Faculty of Electronic Circuits - delegated to implement a project of electronic ignitor for discharge lamps at Rzeszów - Polam discharge lamp manufacturer.

# 4) Andrzej Ziemiński

Andrzej Ziemiński has tertiary education - graduated from the Warsaw School of Economics, majoring in Banking and Finance. He has more than 14 years' experience in management, restructuring as well as mergers and acquisitions. His professional career includes executive and non-executive board functions at telecom and new technologies companies.

He was Member of the Management Board in Impera Capital SA, and since 2011, Member of the Management Board at Impera Seed Fund Sp. z o.o., an entity managing the equity fund initiated by Impera Capital SA and KFK-Krajowy Fundusz Kapitałowy. From 2010 to 2013 he was a partner and the Member of the Management Board o Supernova Fund.

In 2007-2009, he was President of the Management Board at PPWK SA, which he transformed from a traditional map publishing house into a B2B supplier of telecommunications and mobile services. With the funds raised through a public placement and a series of successful acquisitions, including those of Neotel Communications Polska Sp. z o.o and Długie Rozmowy SA, the process was completed in 2 years. From 2004 to 2009, President of the Management Board at EL2 Sp. z o.o., a provider of applications and services in Value-Added Services for GSM Telecommunications. His current functions include Supervisory Board membership at such companies as: Dominium SA, Telemedycyna Polska SA, Listonic Sp. z o.o., Simplum Sp. z o.o.
